## HALL OF FAME NOMINATION PROCESS

### **(MERITORIOUS SERVICE)**

**H.O.F. Nominations submitted to the Board of Directors of the Baldwin County Bowling Association (BCBA) for consideration should be kept "Confidential".**

**FOR A BOWLER TO BE CONSIDERED AS A CANDIDATE FOR HALL OF FAME INDUCTION THE FOLLOWING REQUIREMENTS MUST BE MET:**

**NOTE: 2021 is the Inagural Year for the Baldwin County Bowling Hall of Fame. A total of (10) Hall of Fame inductees (Superior Performance + Meritorious) is allowed. Subsequent years will allow a total of (5) inductees.**

**1** **CANDIDATE MUST BE RECOMMENDED IN WRITING BY A MEMBER IN GOOD STANDING OF THE BCBA BOARD OF DIRECTORS.**

**2** **A BCBA HALL OF FAME NOMINATION FORM MUST BE COMPLETED IN DETAIL. ALL INFORMATION MUST BE FILLED IN.**

**NOTICE: A NOMINATION FORM SUBMITTED 'INCOMPLETE' WILL NOT BE ACCEPTED FOR CONSIDERATION.**

**3** **THE LETTER OF RECOMMENDATION WITH THE COMPLETED NOMINATION FORM MUST BE RECEIVED NOT LATER THAN **AUGUST 1st.****
